LED LIGHTING FIXTURE WARRANTY STATEMENT & LIMITATION OF LIABILITY

Sunpark Electronics Corporation warrants that LED Lighting Fixture approved by Energy Star or designed per Energy Star specifications shall be free from defects in material and workmanship for a period specified below from date of purchase.

- LED Light Source 5 years
- LED Power Supply (Driver)* 5 years (Please see page two for LED power supply manufacturer contact info)
- LED Fixture Housing 3 year (standard Energy Star fixture warranty)

If any fixture fails to meet the above warranty and if purchaser notifies Sunpark by phone, 866-478-6775, to ask for a RGA number or by FAX, 888-711-2368, or by e-mail in writing within thirty (30) days of discovery of that defect and makes the fixtures available, Sunpark shall thereupon repair or replace said defective Fixtures Housing and/or defective Light Source.

Sunpark Electronics Corporation reserves the right to examine all claims, and reserves the right to be the sole judge as to whether the Light Source and/or Fixture Housing are defective and covered under this warranty, to either replace or repair. All returns for repair, replacement, or for an equivalent, must be approved by Sunpark Electronics Corporation in advance. Sunpark reserves the right to be the sole judge as to whether the Power Supply are defective and covered under this warranty. Sunpark reserves the right to redirect Power Supply warranty claims to Power Supply manufacturer*. All transportation charges are the buyer's responsibility.

The foregoing shall constitute the sole remedy of the purchaser and the sole liability of Sunpark with regard to warranty and Sunpark makes no other warranty, statutory or otherwise, and none is implied.

Sunpark's liability on any claim of any kind, including negligence for any damage arising out of, connected with, or resulting from this warranty, or from the design, manufacture, sale, delivery, resale, installation, inspection, repair, operation or use of the fixture furnished by Sunpark shall in no case exceed the price allowable to the fixture or fixtures which give rise to the claim and shall terminate five (5) years after the date of sale to the purchaser.

IN NO EVENT, WHETHER AS A RESULT OF BREACH OF CONTRACT, WARRANTY, NEGLIGENCE, OR OTHERWISE, SHALL SUNPARK BE LIABLE FOR SPECIAL OR CONSEQUENTIAL LOSS OF USE OF FIXTURES OR ANY OTHER GOODS OR EQUIPMENT, COST OF CAPITAL, COST OF SUBSTITUTION EQUIPMENT, DOWNTIME COST, OR CLAIMS OF CUSTOMERS OR PURCHASER FROM SUCH DAMAGE.
